

# **Fiscal 2019 R&D Subsidies (Overseas)**

## **Notice on Application**

### **General request**

Please do not change the format for pages 1 & 2.

You can freely enlarge or reduce the entry frame for the third and subsequent pages. You may also insert charts within the entry frames.

However, please keep in mind that the total number of pages is within 6 pages.

### **II. Application Amount**

Please enter the amount of money within 3 million yen in 500,000 yen unit.

### **IV. Contact information in Japan**

Be sure to set up contact information in Japan.

For example, researchers from research institutes in Japan, doctors in medical institutions in Japan etc.

### **V. Subsidy Funds, or Supplemental Funds, from other Organizations with Regard to Related R&D**

In the event an applicant is receiving subsidies from other funds with regard to this R&D theme, please state the type of funds, topic of research, period and amounts for no more than three sources, starting with the latest.

There is no need to state unconfirmed items.

### **VI. Joint R&D Partners**

Please write up to 3 people, if there are.

### **Recommendation**

The recommender shall be the immediate supervisor to the applicant.

Note that references are limited to one recommendation.

### **VII. Abstract of Application Contents**

Please include the following points “the extent of contributions to society”, “originality” and “novelty” etc.

### **IX. Purpose of the R&D**

Please state what value this R&D will provide in actual medical settings or other areas, and expected contributions to society.

Examples of value to actual medical settings or other areas: “The ability to accomplish medical treatment or tests that had been impossible”, “Improved treatment results”, “Alleviated side effects”, “Faster healing”, “Making shorter hospital stays possible”, “Reducing patients’ pain or physical burdens”, “Raising the accuracy of medical tests”, “Reducing time needed for medical testing”, “Shortening period of medical treatment”, “Enhanced medical safety”, “The ability to simplify connections between hospitals and home care”, “Lowered infection rates”, and so forth.

Expected contributions to society: content related to contributions to regional communities such as improvement of medical services or public health.

### **XI. Details of Subsidy Purpose**

Please provide an approximate breakdown of funds needed, in line with experiment equipment, experiment tools, test reagents, and other items.

Subsidy purpose shall be expenses directly required by the eligible programs.

Subsidy will not cover overhead costs such as indirect expenses of the applicant’s organization or general administrative costs

Subsidy will not cover personnel expenses of applicants and co-workers.

Please state the experiment and testing process, and their schedules.

Please state the division of roles in the event there is to be a partner jointly conducting the R&D.
